V Reports from members – Emergency Services District 12 Commissioner Ron Fowler reported that ESD 12 is getting ready to build the fire station on Hogeye Road. This will be a 24/7 operation but no ambulance will be attached to the station. He also reported that ESD 12 has realized a \$40,000 increase in income due to the 2% rate increase. Two new custom built fire engines have been ordered because the engines currently in use are "worn out". He also reported that ESD 12 meetings are held on the second Tuesday of each month beginning at 6:30 p.m. at the Manor Fire Station.

Ann Brockenbrough has been in communication with the developers of the Hidden Lakes subdivision located at Parsons and Lockwood Roads. This parcel is 404 acres and Anne is working with the developer to see if the parcel would qualify for partial funding for a ranch to keep the landscape intact.
